DECISION LETTER FROM THE Co-EDITOR OF JPubE

Dear Kerstin (and co-authors),

thank you for submitting your paper "Women's career choices, social norms and child care policies" to the *Journal of Public Economics*. I apologize for the delay in getting back to you.

I have heard back from two expert referees and they are mixed in their recommendation: one recommends R&R, one recommends rejection. I have carefully read the paper myself and enjoyed reading it. I do see the potential of the paper and have decided to give you a chance to revise the paper. However, I should point out at the onset that this is a significant revision and I am not sure that we can get over the concerns I will summarize below. As a consequence, this invitation for an R&R is more speculative than I would like it to be. It will require some careful thinking and creative work on your behalf to elevate and solidify the contribution of your paper and make it suitable for the *Journal of Public Economics*. I will try to be clear below on the goals I would like you to achieve in this revision, but my guidelines are less concrete than they usually are for an R&R.

My overall take is the following: like the referees, I believe you are studying an important question which has received considerable attention in the empirical literature, but for which we are lacking a natural framework to evaluate welfare and to think about policy design. Your paper is trying to fill this gap, which is nice. The paper is well executed overall: the motivation is clear, the writing is clear and the analysis is solid. However, just like R2, I am worried whether the framework you develop provides the novel and relevant insights that warrant publication in the *Journal of Public Economics*. R2 writes to me, "Theoretically and mathematically, the paper is not challenging, moreover it fails to connect to empirical patterns and thus it makes the policy analysis somewhat vacuous. I agree that the failure to link the policy recommendations to empirical patterns is a strong shortcoming for our readership, but I am afraid this is difficult to overcome. Your motivation is well grounded in empirical work, but the absence of this link sets the bar higher for the depth and the clarity of the insights you provide. On that, I don't think the objective should be to make the paper more challenging, but it should be more revealing and more transparent. On the one hand, the current exposition and some differences in policy predictions rely too much on particular modeling assumptions. I will try to be more clear on that below, but for sure these things should be smoothened out. On the other hand, once you strip the model down further and stick to the robust predictions, what remains may feel rather straightforward. However, I think there is an opportunity here to try to realize some of the unexploited potential of your model."

What I will do below is provide some guidance on how to deal with the referees' concerns and then I will list a number of concerns I have in addition, together with some suggestions that could help you addressing my main concerns stated above. If you decide to undertake this revision, please do explain in response letters to me and to each of the referees how you have addressed each of the concerns, point by point. In general, it is important not to only follow the letter of the comments but also follow the intent or spirit of the comments.
