2023-present	<p>The Economics of diversity: A meta-Analysis (in collaboration with Florian De Bundel, UCLouvain)</p> <p>My fourth research project conducts a meta-analysis of the economics of diversity, focusing on the effects of migration pattern diversity on local economic outcomes. Using U.S. and European data, the analysis also examines outcomes at multiple levels of aggregation to reconcile divergent findings in the literature regarding the impact of migration exposure and diversity. The (preliminary) results reveal that both positive and negative effects documented in prior studies can coexist at different levels in a country, providing a more comprehensive perspective on the economic implications of diversity and migration exposure.</p>

2023-2025	The Roman roots of the Western Economic linkages My third research project examines the path-dependence relationship between economic links and political integration in Western Europe under Republican and Imperial Roman rule and economic linkages between the current European regions, to investigate whether the home bias observed in the trade literature is mitigated by strong economic and political integration prior to the emergence of national borders. Based on gravity models that allow the role of several geographical factors to be excluded from the estimates (including current trade costs), it provides empirical evidence that European NUTS2 regions that were highly integrated commercially and/or politically under the Roman Empire trade more and have stronger financial ties and business cycle synchronization in the early 21st century. Joint political integration under the Roman Empire is also associated with a sizeable decrease in the trade Home bias trade between regions belonging to different countries. Additional robustness checks suggest that cultural convergences is one of the main drivers of these observations.
2021	The costs of ending Shengen? Evidence from freight road Data (in collaboration with prof. Jean-François Maydstadt (UCLouvain) and Adam Levai (LISER)) This second research exploited sudden temporary increased controls at the national borders of countries in the Schengen area due to exceptional unexpected circumstances between 2011 and 2020 to estimate the impact of the Schengen area on trade, using regional trade data. The results suggest an absence of impact that may be driven by a lack of effectiveness in these border controls.
2020-2024	Immigrant Birthplace and Wages: Evidence from new US migration flows My first working paper relates to migration economics and the impact of immigrant birthplace diversity on local economic outcomes. This research examines the relationship between workers' real hourly wages and birthplace diversity in American metropolises at the beginning of the 21st century. By taking a more granular approach focusing on diversity at the level of local groups of workers, it disentangles the effects of birthplace diversity from other forms of heterogeneity, including occupation, industry, and workplace. This local level is also likely to capture the mechanisms associated with the exchange of ideas or conflicts as these are more likely to occur among individuals in the same local industries and professions due to the higher level of interactions and the local market mechanisms. This study explores both the positive effects of diversity on wages through increased complementarity among workers and the potential challenges arising from communication barriers and social tensions. Finally, it exploits variations in the migrant population composition arising from the increasing extra-European migration size and diversity to take into account cultural, norms, and background differences related to local diversities using a various panel of measures of cultural distances in augmented diversity indexes. The findings support a robust positive impact of immigrant birthplace diversity on (natives) wages at this granular level that differs from past literature findings at broader levels, and this relationship is stronger when diversity arises from migrants coming from high-income countries.
