The Political Economy of Informality:

Why are some organizations representing urban informal workers, the least likely to influence politics, more successful than others at shaping policy implementation? I tackle this question



combining the analysis of social policy program implementation data, original surveys among informal workers and leaders, and extensive field research in two country cases: Argentina and Mexico. My research shows that informal workers' organizations can achieve influence in the policymaking process beyond their role in clientelist machines, and that by doing so they also contribute to shaping the preferences of those to whom they seek to give voice. Each part of my dissertation assesses these issues at a different level of analysis tailoring the empirical strategy to understand territorial, organizational and individual dynamics.
