#### TRAINING OR RESEARCH ACTIVITY

#### Research activity

I am an applied microeconomist, with research interests lying in the fields of labor, development and environmental economics. Many of my projects analyze the impact of polices aimed at supporting economic or social minorities, in developed and developing economics. The projects "Public Kindergarten, Maternal Labor Supply and Earnings in the Longer Run: Too Little Too Late?", "Parenthood and life satisfaction" and "Happily inequal? Recent trends in self-reported happiness and income inequality" focus on the impact of social norms and public childcare facilities on gender inequality in labor market opportunities and in life satisfaction in the USA and in Europe. The projects "Customizing incentives to combat caste- and gender- based discrimination" and "Vulnerable Groups and the COVID-19: The Indian Case" deal with inequality across social castes in India, and how policy interventions can mitigate or aggravate it. "Price Information, Inter-Village Networks, And Bargaining Spillovers" shows the potential for ICT technology to empower smallholder farmers, hence reducing poverty and income inequality in rural regions of Sub-Saharan Africa. My interest in environmental preservation resulted in the paper "Stick or carrot? Asymmetric Responses to Vehicle Registration Taxes in Norway", which estimates the impact of a series of reforms of the private passenger vehicle registration tax system introduced in Norway between 2007 and 2011.

Paper under peer review	Stick or carrot? Asymmetric Responses to Vehicle Registration Taxes in Norway (with Alice Ciccone of the Transport Economics Institute in Oslo) - Vehicle registrations have been shown to strongly react to tax reforms aimed at reducing CO2 emissions from passengers' cars, but are the effects equally strong for positive and negative tax changes? The literature on asymmetric reactions to price and tax changes has documented asymmetries for everyday goods but has not yet considered durables. We leverage multiple vehicle registration tax (VRT) reforms in Norway to show that, within car model, new car registrations react to tax cuts and rebates significantly more than to tax increases. The estimated elasticity is -1.99 for VRT decreases and -0.77 for increases.
Paper under peer review	Price Information, Inter-Village Networks, and "Bargaining Spillovers": Experimental Evidence from Ghana (with Nicole Hildebrandt at Boston Consulting Group, Yaw Nyarko at New York University, Giorgia Romagnoli at University of Amsterdam) - Through a randomized experiment and detailed data on communications across farmer com- munities, we identify the impact of text-messages-based commodity price information on rural farmers revenues. The intervention affected prices received by farmers in two ways: (1) a long- lasting increase of about 9% for treatment group farmers, and (2) substantial indirect benefits for certain control group farmers, which cannot be explained solely by classical informational spillovers. We discuss a novel mechanism of bargaining spillovers which can explain the rise of such positive externalities, even in the absence of information sharing between the treatment and control groups. Our results highlight the importance of accounting for longer-run spillovers and the potential of ICT interventions in emerging markets.
Paper under peer review	Public Kindergarten, Maternal Labor Supply and Earnings in the Longer Run: Too Little Too Late? - By facilitating early re-entry to the labor market after childbirth, public kindergarten might positively affect maternal human capital and labor market outcomes: are such effects long-lasting? Can we rely on between-individuals differences in quarter of birth to identify them? I isolate the effects of interest from spurious associations through difference-in- difference, exploiting across-states and over-time variation in public kindergarten eligibility regulations in the US. The estimates suggest a very limited impact in the first year, and no longer run impacts. Even in states where it does not affect kindergarten eligibility, quarter of birth is strongly and significantly correlated with maternal outcomes.



2020	Vulnerable Groups and the COVID-19: The Indian Case (with D. Rustagi at the University of Nottingham and R. Ramachandran at the University of Heidelberg) – Project commissioned and funded by Oxford Policy Management (2,500 GBP). The COVID-19 pandemic poses severe challenges not only on the health front, but also for the economic and social systems around the globe. It can exacerbate longstanding inequities between groups and leave marginalized groups in a vulnerable position. In the context of India, we believe that the pandemic particularly endangers individuals belonging to the traditionally socioeconomically disadvantaged groups. Based on novel micro data and a careful review of previous literature in economics, sociology, history and medicine, we argue that Scheduled Castes (SC) individuals faces three main risks. First, their low social status forces them to live in conditions that put them at high risk of acquiring COVID-19 and other diseases; second, their poor economic status makes them particularly vulnerable to the economic crisis induced by the pandemic; third, the atmosphere of uncertainty and fear stemming from COVID-19 may lead to a surge in stigma and mistrust, aggravating existing discrimination against such groups.
Ongoing	Customizing incentives to combat caste- and gender- based discrimination (with D. Rustagi at the University of Nottingham and R. Ramachandran at the University of Heidelberg) - The project has been funded (approximately 50,000 GBP) by the UK Department for International Development (DFID) and is part of the Economic Development and Institution programme, supported by researchers at CEGA in Berkeley, the Paris Schools of Economics and University of Namur. Using observational and registry data, we document how the academic achievement of girls and students from scheduled castes and tribes (SC/ST) are substantially lower than those of general caste boys in India. We develop an ad hoc toolkit of lab-in-the-field measures which allows us to (i) assess how much of the gap in outcomes can be imputed to discrimination by teachers; (ii) determine whether such discrimination is best described as implicit association, taste discrimination or statistical discrimination; (iii) test the impact of several alternative policies to reduce discrimination.
Ongoing	Parenthood and life satisfaction (preliminary title) – This project received funding from the Fokus Grant for early researchers. The challenges posed by the need to juggle family life and career do not only impact parents' labor supply, but also their wellbeing. Data from the European Social Survey reveals that, ceteris paribus, women on average report higher levels of life satisfaction than men. Focusing solely on individuals with children, however, the picture appears very different, with mothers reporting lower life satisfactions than fathers. I investigate the reasons for such reversal of the gender gap in life satisfaction, using data on individuals with migration background to isolate the impact of social norms.
