description of activity

 Between October 2016 and September 2017, I took 10 obligatory advanced courses for my Ph.D. and I have passed them all • In October 2017, I obtained the approval of my supervisor Professor Rita D'Ecclesia to conduct a series of research papers for my PhD Dissertation in the Syrian Banking Sector which is called "Topics in banks' profitability, risk and efficiency" which aim to assess the profitability, efficiency, competition and their determinants of the Syrian banking sector before and after the Syrian Crisis and attempting to model the optimal performance of the banking sector in Syria in relation to the Crisis. ● During Nov, Dec (2017) and Jan (2018), I met with my supervisor Professor (in late Oct.) Rita D'Ecclesia and we managed to set up a brief outline of the research including its financial and econometrical approach. After setting this up, I had to travel to Syria to start working on my research. During my stay in Syria (which lasted from November 2017 up until August/2020 with frequent visits to Rome during this period as I will mention below), I had to visit state-owned banks (3 banks), private banks (14 banks), Central Bank of Syria, Ministry of Finance, Ministry of Economy and foreign Trade, Central Bureau of Statistics in Syria and Ministry of Labor and Social Security. These visits required meeting different officials which were based on the purpose of each visit. For banks, officials from the Finance departments and Corporate departments were met including some staff from Internal audit, Retail banking and Compliance. As for the ministries, directors of several departments were met at each ministry to obtain the necessary information required for the research since a great proportion of the data required

highly ranked officials' clearances to obtain due to the nature of this information especially with the crisis that is going on in Syria. • During March, April, May and June (2018): Continued work on my research and continue to make the visits mentioned above. • In August and half of September 2018, Continued work on my research and continue to make the visits mentioned above. • On 26th of September 2018, I attended the workshop which was organized by the Board of the PhD School for 31st and 32nd Edition PhD students in which I presented the key aspects of my research work. • From February 2019 up until September 2020, I was working on my Ph.D. third paper related to the impact of cost and profit efficiencies on the profitability and risk of the Syrian Banking Sector and I was approved to work jointly with Prof. Giovanni (Professor of Econometrics and Finance and Director of the Centre for Econometric Analysis, Cass Business School, City University of London, London, UK), hence, along with my main supervisor Prof. Rita D'Ecclesia-Professor in Quantitative Methods in Economics and Finance (La Sapienza University of Rome, Rome, Italy)-Visiting Professor at Birkbeck University of London, I also was under the supervision of Prof. Urga, I was constantly moving between Rome and Damascus (Syria) for collecting my data, building up the models and simulate several scenarios for my paper. • In September 2020, I submitted my three Ph.D. papers to the school to be examined by several external referees before being able to defend my Ph.D. thesis in December 2020 • I attended several seminars in the years 2017-2019 which will be detailed below in the section of "seminars attended"
