# PUBLIC COMPETITION FOR 12 MONTHS TYPE B FELLOWSHIP FOR COLLABORATION TO RESEARCH ACTIVITIES IN THE SCIENTIFIC AREA OF POLITICAL AND SOCIAL SCIENCES

#### ART. 1 - COMPETITION NOTICE

According to art. 3 of Regulations, a public competition notice by qualifications and examinations is announced for the assignment of a Type B Fellowships to carry out research activities lasting 12 months for the scientific area of political and social sciences restricted to doctorate graduates or graduates.

#### ART. 2 - REQUIREMENTS

All graduates who have an appropriate scientific-professional curriculum to carry out research activities established by this competition notice can participate in this public selection.

PhD or equivalent qualification obtained abroad accompanied by an appropriate scientific production is a preferential requirement for admission, according to this competition notice.

Candidates must meet the following requirements:

- a. Absence of criminal record;
- b. Degree in Political Science or equivalent, from an Italian or foreign university.

Moreover it is required:

- c. Expertise in research area proven through participation in research activities, attendance to specific academic courses and / or scientific publications in the following fields: Comparative European welfare states/social policies, European social governance, European integration, institutional analysis. Proven expertise in the use of at least one of the following research methods: case study, advanced process tracing, expert and elite interviewing, focus forums.
- d. Knowledge of language: Italian and English

Qualifications must be owned within the deadline established for the presentation of the application form.

Applicants in possession of degrees obtained abroad, who do not own a declaration of equivalence, will have to enclose a translation into Italian or into English of their foreign degree, (Degree with marks earned in each examination and PHD degree certificate) accompanied by a self-certification stating that the translation is a true and faithful copy of the original.

The degree earned abroad can be declared admissible, by the Judging Commission, only for purposes related to the selection.

The following qualifications will be evaluated for purposes related to the competition:

- a. PhD in subjects concerning the research or equivalent qualification earned abroad;
- b. Specialization degree in subjects concerning the research;
- c. Post-graduate degrees;
- d. Attendance of post-graduate courses at Italian or foreign Universities;
- e. Scientific-professional curriculum based on proven experience for research activity already carried out at public and private bodies with contracts, fellowships or appointments, both in Italy and abroad;
- f. Publications in scientific reviews.

#### ART. 3 - CANDIDATES LIST AND CURRICULA PUBBLICATION

#### ART. 4 - APPLICATION

Application forms in plain paper must be written according to the form at the following link: <u>https://www.unimi.it/it/ricerca/fare-ricerca-da-noi/assegni-di-ricerca</u> and include name, surname, place and date of birth, address, telephone number, competition notice information. Due to the Covid 19 epidemiological emergency situation and the reduction of services of University offices, they must be submitted online, at the following email address: <u>unimi@postecert.it</u> and <u>assegni.ricerca@unimi.it</u>, within <u>January 08th 2021 at 11:59 pm</u>. The application form and any other enclosures requiring the candidate's signature. The message should state in the object field:

Application forms not signed or incomplete or sent after the deadline established will not be admitted.

The application form must enclose:

- a. Degree with final mark;
- b. Phd degree / specialization in medical area;
- c. Scientific qualifications, diplomas, scholarships, attendance of post-graduate courses,



- d. Publications
- e. Curriculum of scientific activities.

The above-mentioned documents can be presented as follows:

Academic and professional qualifications can be self-certificated (Enclosure 1). Other qualifications which require evaluation, publications included, can be presented in original copy or in photocopies by self-declaration according to DPR 28/12/2000 n. 445 (Enclosure 2).

Candidates who only have a graduation degree must enclose the necessary documents to demonstrate a scientific-professional curriculum and appropriate research experience to carry out research activities as stated on this competition notice, otherwise they will be excluded from the competition.

#### ART. 6 - RESEARCH ACTIVITIES

The Fellowship implies carrying out the activities briefly mentioned below at **Dipartimento di** Scienze sociali e Politiche dell'Università degli Studi di Milano and under the supervision of Prof. Matteo Jessoula within the research "EUROSHIP - Closing gaps in social citizenship. New tools to foster social resilience in Europe" of the activities mentioned below:

- 1) Conduct a literature review and document analysis aimed at reconstructing and assessing the policy tools available at the EU level in promoting upward social convergence. This task includes an analysis of the changing EU social policy tool-kit connected with the European Pillar of Social Rights (EPSR) to outline the main developments and initiatives and a parallel, in-depth, review of recent scholarship on the EU's social dimension. Based on this work, drafting a working paper: "The social dimension of the European Union: facts, figures and views"
- 2) Explore the political dynamics underpinning supranational social initiatives by analyzing the political dimension of two key policy initiatives at the EU level within the European Pillar of Social Rights. Based on this research, contribute to drafting two working papers.
- 3) Identify ways for national social protection systems (income maintenance, social services, social regulation) to prevent social exclusion in the digital economy. This work will primarily rely on interviews with chief digital officers and focus forums with relevant societal organisations trying to reduce the digital divide.
- 4) Actively contribute to organize meeting/events planned in the Euroship workplan as well as dissemination activities.

# ART. 8 - FELLOWSHIP AND INSURANCE

The Fellowship's yearly gross amount is of **Euro 33.347,00**. The amount is tax free according to art. 4 Legge 13 August 1984 n. 476 and subject, for what concerns welfare regulations, to regulations as from art. 2 paragraphs 26 and following Legge 8 August 1995 n. 335.

The university will provide, for the period of the fellowship, private insurance cover with a public liability insurance and accident insurance to the fellow. The insurance premium is directly subtracted each year from the remuneration of the fellow.

#### ART. 9 - PAYMENT AND SUPERVISION

The amount is paid in postponed monthly instalments. The Fellows' duties, established by the individual contract, are performed under the supervision of the coordinating Professor, who will verify that the activities are carried out according to art. 8 paragraph 5 of Regulations.

#### ART. 10 - SELECTION PROCESS

Application forms will be examined by a judging Commission, specifically appointed by the Rector (for the composition of the Commission see Regulations, art. 3 paragraph 2). The Commission, within twenty days since the deadline for presenting applications, will produce a report ranking the candidates on the basis of a selection of academic and scientific qualifications presented and of an interview aiming at verifying the candidate's aptitude to research and knowledge of the language required. The commission establishes the standards of evaluation at the beginning of the selection, and will evaluate the candidate using up to 100 points, to be divided as follows:

- 1) PhD or Specialization in Medical Area up to 15 points
- 2) Scientific-professional Curriculum (post-graduate degrees, certified experience for research activity already carried out at public and private bodies with contracts, scholarships or appointments, both in Italy and abroad) up to **10** points
- 3) Other qualifications established by the competition notice up to **15** points
- 4) Scientific publications up to **10** points

and for the interview up to 50 points.

On the basis of the evaluation of the qualifications, the Commission writes the list of those who will be interviewed. A minimum score equal or greater than **30** points is needed in order to be admitted to the interviews. The list of candidates admitted to the exam-interview will be published on the same page on which this announcement was published. The Commission at the

end of the interviews will publish the result of the total evaluation for each candidate and will form a ranking on the grounds of the points earned by each candidate, and appoints the winner or the winners when more fellowships must be awarded. The minimum overall score for admission to this position is **70** points out of 100. In case of equality the youngest candidate will be preferred. The results of the selection are approved by Rector's decree and published on the University web site. Reports by Commission are public.

The interview is public and will take place on <u>January 15th 2021 at 11 am</u>. Due to the Covid 19 epidemiological emergency situation, the interview will take place in a telematic way.

Disabled candidates, according to Legge 05/02/1992 n. 104, shall explicitly request the necessary aid in order to participate to the interview.

Candidates living abroad can ask for an interview with electronic procedures, pending authorization by Examination Committee. Candidates should contact the Direzione Risorse Umane - Ufficio Contratti di formazione e Ricerca (<u>assegni.ricerca@unimi.it</u>), at least one week before the date of the interview, to verify in advance the feasibility. The dates of the interviews are shown in art.10 of this call.

The winner will receive communication, by registered letter with acknowledgment of receipt, to the address written in the application form, of the assignment of the fellowship. Within 15 days since receiving the communication, unless differently stated, the person concerned must send the Rector the declarations of acceptance required by the Administration, otherwise he/she will lose the right. Within the following 10 days he/she will be called to sign a contract of collaboration to research activities.

Candidates who earned their degree abroad and are the winners must send to this Office, together with declarations of acceptance required by the Administration, the official translation of their foreign degree, as officially certified by qualified Italian diplomatic or consular representations in the country of origin, according to laws in force. Candidates will be excluded from the selection in case documents do not arrive within such deadline.

For non-EC citizens the fellowship will start after obtaining the entrance visa for scientific research and when research activity actually begins.

The winner's personal statements, facts and certificates will be properly checked by Università degli Studi di Milano.

Declarations and certifications sent in one envelope by registered letter with acknowledgment of receipt (stamp and date of the post-office will be considered as proof) will be considered sent in time within the deadline mentioned;

If the activities imply the use of laboratories, work equipment, chemical, physical and biological agents, inclusive of equipments provided with visual display units, the Fellow, according to art. 41 Dlgs n. 81/08, will undergo prior medical examination in order to verify counterindications with reference to activities which the subject should carry out and to evaluate his/her suitability.





# ART. 11 - WINNER NOT COMPLIANT WITH COMPETITION NOTICE AND REGULATIONS

Winners of fellowships who do not comply with the rules of this competition notice and the University Regulations will lose the right to the fellowship upon Rector's act by previous written communication.

# ART. 12 - PLACE AVAILABLE IN CASE OF LOSS OF RIGHT OR RENOUNCE BY WINNER

In case of loss of the right or lack of stipulation within the deadline established or possible renounce by the winners, fellowships are made available to the candidates usefully placed in the ranking that, according to what established by Regulations, is valid up to ninety days from the approval of acts.
