

Dear Candidate,

thank you for your interest in the Competition for Senior Assistant Professor (Tenure Track) issued by University of Milan - Department of ECONOMICS, MANAGEMENT AND QUANTITATIVE METHODS.
Please find below some FAQs, covering some related issues.

1. Call and application templates

Please see the call and annexes in attachment (direct download [here](#)).
You are kindly asked to read the call carefully, before starting the process.

2. Is the TAX IDENTIFICATION NUMBER (CODICE FISCALE) mandatory for foreign people?

Codice Fiscale is not requested for foreign candidates.

For example, when the candidate enters a foreign country in the "Comune di nascita" (birthplace) field (chosen from the drop-down list generated after typing the first characters), automatically the application no longer requires neither typing the Tax Identification Code in the appropriate field, nor uploading a copy of it.

Please note that it is mandatory if you win the Competition. Please find [here](#) how to apply for the Tax Identification Number for foreign citizens.

3. Do I need PEC (Posta Elettronica Certificata - Certified mail) to send my application?

No, you don't. You are kindly asked to submit your application on SICON Platform.

However Posta Elettronica Certificata- [Certified Mail](#) can be useful to deal with Italian Public Administration.

For example, you must use PEC to apply for EQUIVALENT QUALIFICATION of PhD title (see question 6 and 7).

4. How can I submit my application?

The application consists in two steps:

a) registration as external at this link:

https://www.unimi.it/reg_utenti_esterni/registrazione/form.html

When you receive a confirmation email you can go ahead on SICON Platform.

b) uploading the application and annexes on the SICON platform (only in Italian)

To join the SICON platform you should use:

5. Is the SICON Platform available in English?

At the moment, the SICON Platform is available only in Italian.

6. Which are the Admission requirements?

You can find the requirements in the Article 2 of the Call.

If the **doctoral degree was not achieved in Italy**, the candidate is asked to provide EQUIPOLLENCE QUALIFICATION (please see the instructions [here](#), only in Italian) or EQUIVALENT QUALIFICATION (please see the instructions [here](#)).

7. Is the equivalence/equipollence qualification of PhD title mandatory at this stage?

No, it isn't. It is required in case you win the competition, when you sign the contract.

At this first step, **you must upload the proof that you sent the application for this title** (e.g. screen shot of the email sent or email return receipt).

However, you are kindly asked to start the request ASAP, due to the duration and complexity of this procedure.

8. Italian language

According to the Call, foreign citizens must declare to have adequate Italian language proficiency.

However, the Department offers several teaching programs in English; during the selection, a commitment to learn Italian upon recruitment will be requested.

9. Can I send the application via email?

No, you can't. The application for the present selection procedure **must be completely and exclusively filled in and submitted online, by using the IT platform available on the University of Milan website, the SICON platform.**

10. How should I upload the annexes A, B and C?

Annex A, B and C must be uploaded on SICON PLATFORM in the ALLEGATI Section.
