Partial amendment to Rector's Decree no. 1652/2026 of 24/04/2026 - public selection notice for recruiting 3 contract researchers at the Department of Philosophy "Piero Martinetti", by entering into a 2-year employment contract under art. 22 of Law no. 240/2010

THE RECTOR

HAVING REGARD TO Law No.240/2010 of 30/12/2010 concerning "Regulations on university organisation, academic staff and recruiting, as well as proxy to the Government for improving university quality and efficiency";

HAVING REGARD TO Legislative Decree no. 33/2013 of 14/3/2013 "Reorganisation of the discipline regarding disclosure obligations, transparency and dissemination of information on behalf of the Public Administrations";

HAVING REGARD TO Rector's Decree no. 1711/2025 of 27/3/2025, with which have been issued the University Regulations for the appointment of research contracts, pursuant to art. 22 of Law no. 240/10 of 30/12/2010;

HAVING REGARD TO Rector's Decree no. 5499/2025 of 11/12/2025, issuing amendments and additions to the University Regulations for the appointment of research contracts;

HAVING REGARD TO Rector's Decree no. 1652/2026 of 24/04/2026, by which this University announced a public selection procedure for entrusting 3 posts as contract researcher by entering into a 2-year employment contract at the Department of Philosophy "Piero Martinetti", procedure code 500067;

HAVING ACKNOWLEDGED THAT, due to a mere material error, art. 1 of the aforementioned Rector's Decree no. 1652/2026 of 24/4/2026 incorrectly indicated the scientific-disciplinary sector covered by the selection as SSD PHIL-05/A - History of Philosophy, instead of SSD PHIL-05/C - History of Medieval Philosophy;

DEEMING IT NECESSARY to partially amend art. 1 of Rector's Decree no. 1652/2026 of 24/4/2026, exclusively with regard to the scientific-disciplinary sector covered by the selection procedure, procedure code 500067;

HEREBY DECREES AS FOLLOWS

Art. 1

In view of the foregoing premises, art. 1 of Rector's Decree no. 1652/2026 of 24/4/2026, in the part concerning the scientific-disciplinary sector covered by the public selection procedure for entrusting 3 posts as contract researcher by entering into a 2-year employment contract at the Department of Philosophy "Piero Martinetti", procedure code 500067, is amended as follows;

Scientific-disciplinary sector: **PHIL-05/C - History Of Medieval Philosophy**

Art. 2

The remaining content of Rectoral Decree no. 1652/2026 of 24/4/2026 is hereby confirmed.
