INSTRUCTIONS

- Applicants are required to pay a stamp duty of € 16: one for the application form plus one for each certificate
 requested. Payment have to be submitted using the on-line system <u>Payment Service</u> Contributi per prestazioni
 d'ufficio Imposta di bollo.
- 2. Submit the application form:
- 2.1 Throught InformaStudenti attaching the payment receipt of the stamp duties. If the applicant will log in as external user, it will be necessary to attach also a scan of the ID document. The certificate will be sent electronically through InformaStudenti.
- 2.2 At the front office, by booking an appointment using <u>InformaStudenti</u>. In this case, stamp duties in paper form e.g., purchased at the Tabacconist can be submitted (one for the application form, and one for each certificate request). It is possible to delegate a third person with signed proxy and photocopy of the identity document of the delegating party.

Access to the online services

Access to the online services with the credentials of the University. In case of forgetfulness you can recover them through the <u>dedicated service</u>.

Users without University credentials can make a <u>new registration</u> to the portal as an external user.

Signature of the certificate

- 1. Certificate are normally issued with mark en lieu of signature, pursuant to National Decree leg.vo 39/93.
- 2. If the applicant needs a signed certificate, the Head of the relevant office will digitally sign the document. The digital signature has the same value of the handwritten signature.
 - If a handwritten signature is requested for a certificate needed overseas or for any other need the certificate will need to be collected at the front office. In alternative, home delivery can be requested. In this latter case, applicant will be required to pay the delivery charge: € 10,00 euro (delivery in Italy) or € 15,00 euro (overseas). Fees have to be submitted using the on-line services Payment Service Contributi per prestazioni d'ufficio Oneri per spedizione documenti.
