Research work will be based at the University of Milan, Dept. of Studies in Language Mediation and Intercultural Communication.



Description:

The central idea of this interdisciplinary project is to explore the efficacy, limitations and future applications of theoretical, methodological and pragmatic approaches in the analysis of new recent crisis phenomena in Europe. The stability of the EU as a political and economic union can be discussed from a variety of perspectives (among which Cultural Studies and Postcolonial Studies will have a major focus) in order to outline new interconnected strategies that will be beneficial to the research practices of students and scholars working in the Humanities and Social Sciences. Issues of race, resistance, diaspora, bordering, space control, discrimination, inequality, inclusion, human rights, citizenship, historical memory, neo-colonialism, neo-liberalism, globalisation, regionalism, everyday practice, the Arts (literary, visual, audio, performative) and life-writing will be addressed. Original contributions will be welcomed. The project "Crisis and Risk in postcolonial Europe" will benefit from international contacts with scholars, artists, activists and students in the civil society and groups of research, that have been already established outside the LERU in the universities of Chemnitz, Oxford, Oxford Centre fo Life Writing (OCLW), London





(SAS), Cardiff, Glasgow-Strathclyde, Kent at Canterbury, and North Carolina at Chapel Hill. The research project builds on previous and ongoing initiatives on related themes: (1) Conference programmes devised by Claudia Gualtieri of the University of Milan and Prof. Cecile Sandten of the Technische Universität of Chemnitz: (1a) 1-5 December 2014, Conference "Cultural Studies Workshop. (2) "Hostile Environments: Policies, Stories, Resposnes" with the University of Kent at Canterbury and other institutions, sponsored by The British Academy's programme "Tackling UK's challenges".
