Documents

1. In the first page of the Fellowship form please insert personal information and ways of payment. You can use the same form for following modifications of bank account, residence, domicile etc. to communicate within the 4th day of the month concerned.

Procedure

As from 10/01/2017 ,the annual gross amount of the scholarship will be Euro 16.350,00.

The payment of the contribution will be made by University, after the registration to separate management. The registration, by the PhD student, can be done in two ways:

- a. By web: <u>www.inps.it</u> \rightarrow SERVIZI ON-LINE \rightarrow Per tipologia di utente \rightarrow parasubordinato: iscrizione accesso con pin on line (after the half of the page);
- b. By going personally to an Inps office. The nearest to University is in Piazza Missori 8 20122 Milano (MM Missori)

The activity of the PhD - XXXVII° cycle starts from the beginning of the academic year of the fellowship: 01/10/2021 and the payment will be monthly postponed.
