Call for Applications for 2025 Housing Grants for Non-Resident Students Enrolled at the University of Milan in Academic Year 2024/2025 (art. 1, paragraphs 526 and 527 of the budget law of 30 december 2020, no. 178; art. 6, paragraphs 1-bis and 1-ter of Legislative Decree No. 45 of April 7, 2025, converted by Law No. 79 of June 5, 2025; Ministry of Universities and Research Decree No. 630 of September 10, 2025 - financial year 2025)

Issued by rectoral decree no. 3969/2025, September 19, 2025

It is issued the call for applications for the assignment of the contribution for the housing rental costs incurred during the calendar year 2025 by off-site university students enrolled in the a.y. 2024/2025 at the University of Milan.

Article 1 – Eligible Students and General Application Requirements

- 1. Eligible candidates are non-resident students enrolled at the University of Milan in academic year 2024/2025 who:
 - reside in a place located in a province other than that where the leased property is located;
 - hold a regular lease agreement in 2025, registered no later than 22th September 2025, for a property near the university department they attend.
- 2. Applicants must meet the following requirements:
 - a) having incurred rental expenses during the financial year in question (2025)
 - b) meet the merit requirements indicated in article 1, paragraph 255, letters b) and c), of Law no. 232 of December 11, 2016 (at least 10 credits by August 10, 2024 for enrollment in the second year and 25 credits in the 12 months prior to August 10, 2024 for enrollment in years subsequent to the second year and up to the first year outside the normal duration of the course). This requirement is not applicable to students who meet the conditions indicated in article 3, paragraphs 3 and 1, of Law No. 104 of February 5, 1992, or who have a disability with a disability rating of 66% or more;
 - c) have not been beneficiaries of any << other public grants for housing >> for academic year 2024/2025 including housing services as well as financial aid, including the regional scholarship for non-resident students, since it also includes, pursuant to the applicable legislation and specifically article 7, paragraph 2, of Legislative Decree no. 68/2012, the costs relating to accommodation;
 - d) not be enrolled in the first year of a university course more than once;
 - e) have a University ISEE indicator not exceeding €20,000. To this end, it will be considered the most recent ISEE, as held by the University for academic year 2024/2025;

The student may also use the current ISEE ("ISEE corrente") pursuant to art. 9 of DPCM 159/2013 when, despite already having a valid ISEE, there is a change in the work situation or an interruption of social security, welfare and indemnity payments not included in the total income (as declared for IRPEF purposes) for one or more members of the family unit, or when there is a decrease greater than 25% in the overall income capacity of the family unit.

Foreign students residing in a place located in a province other than the one where the leased property is located, and with a family unit residing and producing incomes abroad, can submit their application even if they do not hold the University ISEE certificate, subject to verification of the above requirement by the competent office.



Article 2 – Application Deadlines and Procedures

- 1. Applications may be submitted from 22 September 2025, from 9.00 am (GMT+2) to 13 October 2025, until 12.00 (GMT+2).
- 2. Applications must be submitted online at https://www.unimi.it/it/node/52921
- 3. When completing the online application, the following documents must be attached:
 - copy of the lease agreement registered;
 - registration receipt issued by the Revenue Agency.
- 4. Failure to submit the aforementioned documentation or submission of an irregular document shall result in the forfeiture of the benefit.
- 5. Applicants will be notified whether the request has been accepted or not by email to the institutional address assigned by the University, by 15 October 2025. Any requests for evaluation reviews may be submitted no later than 20 October 2025.

Article 3 - Determination of Financial Needs and Allocation of Funds by the MUR

- 1. The needs are determined in relation to the number of students enrolled in state universities in the a.y. 2024/2025, who, upon submission of a specific application to participate in the tender and following all the checks, verifications and any reviews carried out by the university on the applications presented, are definitively identified as beneficiaries of the contribution.
- 2. Within 24 October 2025, the University of Milan, after reviewing the applications also in terms of the prohibition to cumulate the benefit with other public grants for housing, shall notify the Ministry of University and Research (MUR) of the number of students entitled to the grant.
- 3. On the basis of the data received, The Ministry of University and Research, identifies, with an interministerial decree, the amount of the total contribution due to each University and assigns to each individual University the share of the resources based on the number of students from the same communicated to the Ministry.

Article 4 – Payment of the Grant to Students

- 1. The University of Milan, based on the funds allocated by the MUR, shall pay the grant to beneficiary students.
- 2. The contribution to be paid to each beneficiary may under no circumstances exceed the amount of the expenses actually incurred by the student for the rental and documented by the student, as resulting from the appropriate checks carried out by the University.
- 3. The grants shall be disbursed by bank transfer to "Carta La Statale", which must be activated as "Flash Up Studio La Statale", or to the IBAN provided when completing the online application.
